## Content:

- 1. The subject categories covered by these journals are: Anesthesiology, Family medicine, General medicine, General surgery, Microbiology, Nuclear medicine, Obstetrics gynecology, Ophthalmology, Orthopedics, ENT, Pediatrics, Pathology, Psychiatry, Radiology, Respiratory Medicine, Cardiology, Surgical Oncology, Endocrinology, Gastroenterology, Urology, Medical oncology, Neurosurgery, Neurology, Nephrology, Microbiology, Epidemiology, Anatomy, Microbiology, Pharmacology, Physical Med & Rehabilitation, Public Health, Rheumatology.
- 2. All of the content is fully downloadable and printable.
- 3. Content can be accesses through any mobile devices, such as Tablets, mobile phones, computers etc.
- 4. Member institutes will have access to current-year content. Continuous access to the bought content will be maintained when the subscriber renews the subscription.

- 8. Access shall be provided to all institutions willing to access the content through the Uniform Knowledge Resources (ANBAI-NBE) Consortium and have assigned LOI with the coordinators of the Uniform Knowledge Resources (ANBAI-NBE) Consortium
- Access to journals would be set-up on static IPs and the access will be geo-locked. This means, one
  site will be defined as One campus in one region only. Chain of Hospitals, under one name,
  owned/operated by single management, but in separate locations will have to subscribe journals
  separately.
- 10. The Uniform Knowledge Resources (ANBAI-NBE) Consortium identifies 103 institutions as first participants of the Uniform Knowledge Resources (ANBAI-NBE) consortium.
